Introductory Address was given by Mr. Sanjiv Edward, Chief Commercial Officer, Delhi International Airport and Honorary Secretary, ACFI while welcoming the guests from the entire global air cargo logistics industry touched upon many achievements of the air cargo logistics industry also highlighted the positive changes brought by the pandemic in the human behavior from transactional type of relation to close human relations and coming out more strongly to deal with the crisis. Welcome Address was given by Mr. Cyrus Katgara President ACFI.



Mr. Cyrus Katgara welcomed Mr. Hardeep Singh Puri the Hon'ble Minister of State (Independent Charge) Ministry of Civil Aviation, for sparing his valuable time out of his busy schedule and the air cargo logistics industry is obliged for his gracious presence as the Chief Guest on the ACFI Annual Event. He also welcomed Ms. Vandana Aggarwal, Sr. Economic Advisor - MoCA as the Guest of Honor and all the dignitaries and guests on this virtual ACFI Annual Event, on the theme, "Changing Consumption Patterns – Transforming Supply Chains". Mr. Cyrus also thanked all the valuable speakers from various parts of the country and overseas for their participation.

Following were the main important points of his address;-

- i. The overall logistics cost in India is 14%, however, the good news is that the logistics cost by air is 1 to 8% of the CIF value. Therefore, in relative terms, Air cargo is the cheaper mode of transportation.
- ii. Air cargo provides speed to market, zero inventory/warehousing cost, low financing cost, and zero loss of sale. A good example is Apple on the high end and Zara on lower-end both using Air Cargo to succeed. Both are immensely successful companies.
- iii. Going paperless is ACFI's favorite subject. COVID pandemic restrictions have fast-tracked the digital process overnight. What we couldn't achieve in the last 20 years, we achieved in the last few months.
- iv. The 99% of Customs Brokers are doing their bonafide job and coming out clean. However, there may be a fraction of agencies who may not be compliant and this happens in every industry. ACFI's plea to Customs is to look at Custom broker as your partner as the future trend is a collaboration which is much more important than accusations.

Address by the Guest of Honor Ms Vandana Aggarwal Sr. Economic Advisor MoCA- Ms Vandana Aggarwal thanked ACFI for organizing this event on such an apt theme relevant to the current situation. She said that Cargo has been one of the favorite subjects of her department in the ministry always.





The main highlighting points of the address of Ms. Vandana Aggarwal was as under;

- National Air Cargo Policy Outline- One of the unique features were the accomplishments of action plans during COVID period. The contribution of ACFI & other associations was immense.
- Promoted Open Sky Policy- for Imbedding Indian trade system & the requirement of creating transshipment facilities and operation of dedicated freighters.
- Creation of Infrastructure facilities at the airports of the country gone more than 3 times of actual cargo volume moving from and to India.
- Could not provide budgetary support to aviation fraternity /industry to mitigate the losses incurred due to COVID pandemic because of the financial constraints of the government.

 From 25th Mar'2020 the entire country faced Total lockdown due to the COVID-19 pandemic causing the shutdown of country's economic activities witnessing 23.9% contraction in the Indian economy during the initial period of this crisis.



- All the sectors of economic activities have been affected seriously including the Civil Aviation sector but the air cargo logistics segment of the Indian Aviation sector has been resilient.
- A degree of optimism has come up from IMF that in 2021-22 Indian economy will bounce back with 11% growth.
- Government gives full assurance to all the members of the air cargo logistics industry bout the support of the government for the growth of country's economy and such type of events organized by ACFI will help to our growth story.
